1. You must list all items you intend to sell at the craft fair. We prefer a wide variety of items for our customers to choose from. First on the list is first in omission of items will not be allowed if duplicating you will be asked to remove your items not listed on your r.s.v.p. Sheet.
2. You will be given a onetime vendor tax form, this must be filled out and returned to us No later than 3:30 on the November 28th.
3. Write on your r.s.v.p. Sheet your 1st, 2nd and 3rd choices of spaces, you prefer. The earlier we get this back the more likely you are to get the tables you prefer.
4. Payment for your space must be made in the form of a cashers check or money order. **ANY Check personal or business will be returned and may cause a delay in you getting the area you prefer to be in.**
5. The Casino has requested that there be **NO Smoking** in the Ballroom, while this event is going on. This is a large space however, due to the consideration of other crafters, guests and safety of all and our merchandise, we have agreed to this.
6. Because this is a gaming establishment. NO Persons under 21 will be left unattended in the Valley Ballroom.
7. We will be advertising in the Gardnerville as well the Carson City Newspaper. Carson Valley Inn also has their own inhouse newsletter that will have us listed in it. Our event is also put onto the marquee outside of the Carson Valley Inn, on the days of the event.
